### **Description of how your charity's programs helped achieve your purpose:**

- 1) 106 disadvantaged school children and their families experiencing hardship received support with educational resources in our pilot program year. We donated 97 yearly stationery and booklist packs for the beneficiaries to start the school year in 2021 across 13 schools in Brisbane and one in Mackay. (Some packs had 2 students / grade in the one pack).
- 2) We had approximately 36 volunteers from across our community that were youth, unemployed, the elderly and people with a disability who helped to sort, clean, renew and categorise educational resources into storage.
- 3) We diverted approximately 70 x 120 L recycling bins of used and unused stationery from landfill.
